**AOC** – Administrative Office of Court. County level court records compiled into a state level repository.

**DOC** – Department of Correction. Inmate records of people who have spent time or are currently in a state level prison facility. May have probation and/or parole information.

**Parole** – Supervised release of a prisoner that has served time in a state level facility.

**Probation** – Suspended jail time and subject is supervised for a period of time with preset conditions.

**Sex Offender** – Sex Offender Registry. Subject convicted of sex crime (Varies by State).

**Arrest** – Non-conviction.

**Single County** – County level information.
