Parole – Release of a prisoner from incarceration before the full sentence has been served

** **Separate Products Available for Instant Data**

Probation – A sentence releasing a convicted person into the community. Subject to court-imposed terms and conditions

AOC – County level court records compiled into a state level repository.

DOC – Inmate records of people who have spent time or are currently in a state level prison facility. May have probation and/or parole information

SOR – Subject convicted of sex crime. Varies by state.
